What is the purpose of this update?


Description of this fund

This is a single sector fund with exposure to a diversified international equities portfolio. The fund aims to achieve long term capital growth through exposure to equities of companies listed on stock exchanges around the world. This fund is closed to new investors.

What are the risks of investing?

Risk indicator for the AMP International Shares Fund No. 4:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Specific risk




Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$2,726.00 (that is 27.26% of his initial \$10,000). Craig also paid \$0.00 in other charges. This gives Craig a total return after tax of \$2,726.00 for the year.
