What is the purpose of this update?

This document tells you how the Select Conservative fund has performed and what fees were charged. The document will help you to compare the fund with other funds. AMP Wealth Management New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to provide a well-diversified portfolio that primarily invests in lower-risk income assets with a conservative allocation to growth assets. This fund is closed to new investors.

What are the risks of investing?

Risk indicator for the Select Conservative fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

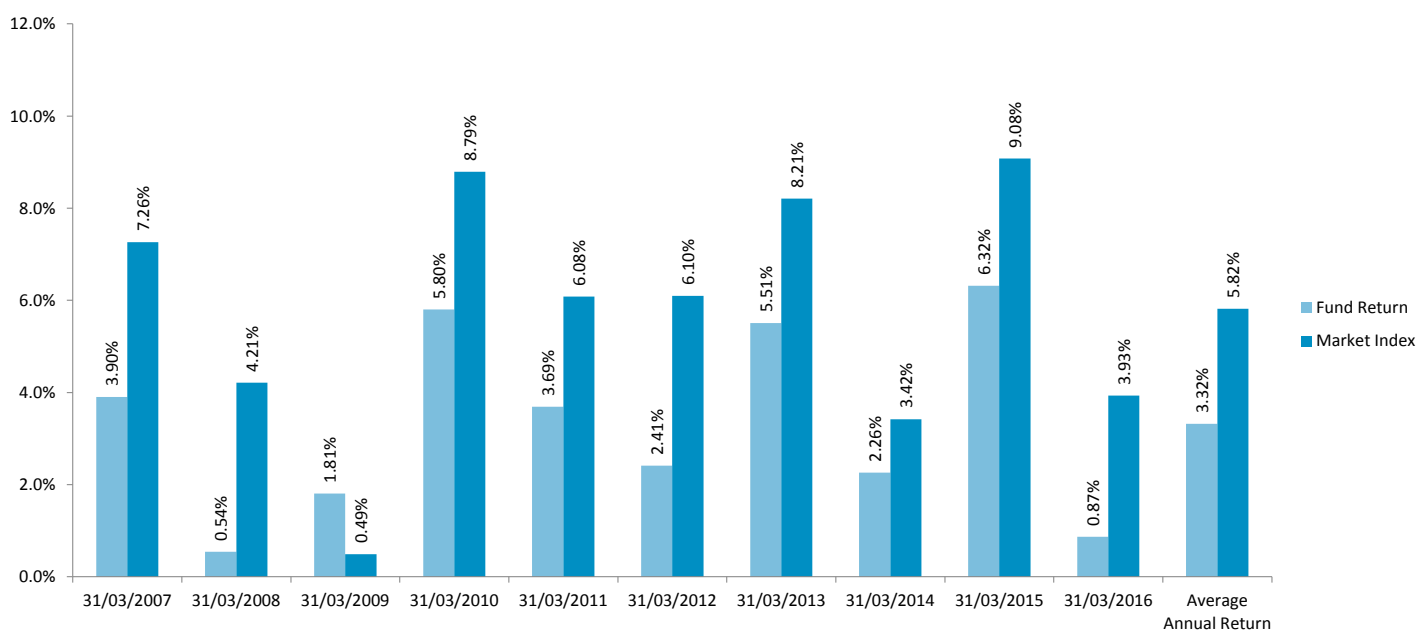

How has the fund performed?

* Based on increased regulatory costs, including a one off cost associated with registering the Scheme under the Financial Markets Conduct Act 2013, and increased administration expenses, the Manager estimates that the total fund charges for the next scheme year will be 2.09% of the net asset value.

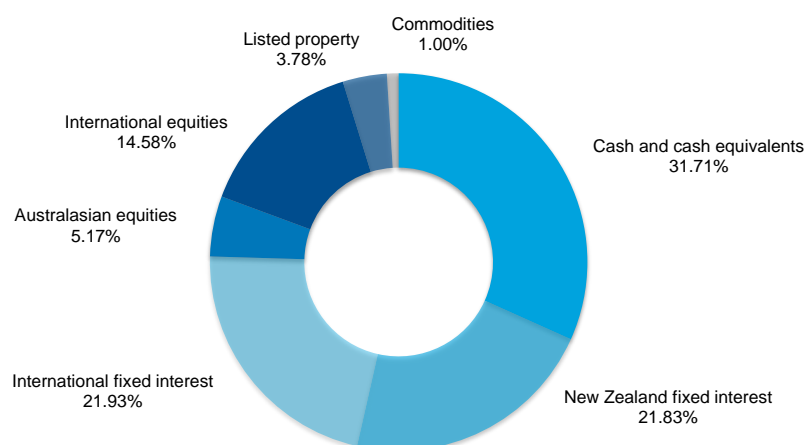
Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$374.00 (that is 3.74% of his initial \$10,000). Craig also paid \$0.00 in other charges. This gives Craig a total return after tax of \$374.00 for the year.
