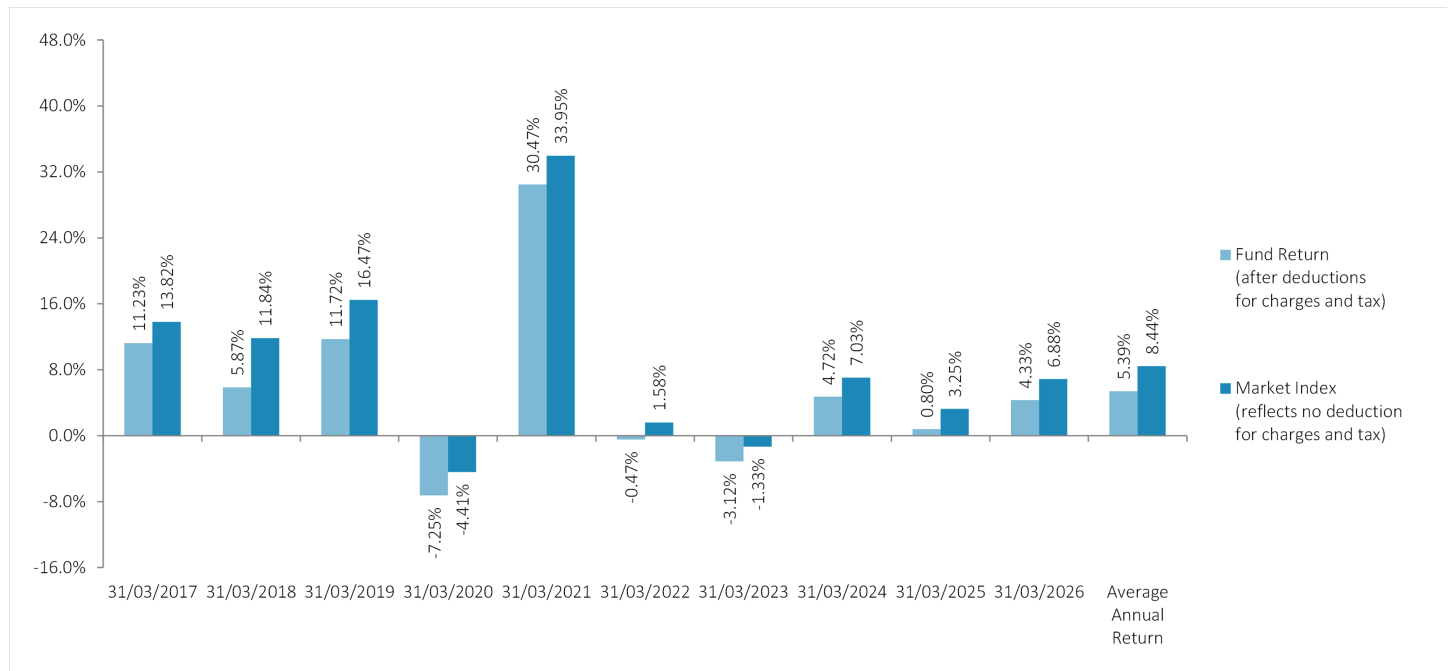




## Annual return graph<sup>1</sup>



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 March 2026.

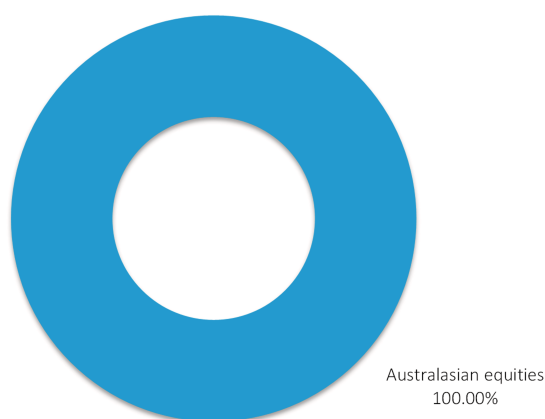
## Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$433.00 (that is 4.33% of his initial \$10,000). Craig also paid \$0.00 in other charges. This gives Craig a total return after tax of \$433.00 for the year.
