What is the purpose of this update?

This document tells you how the NZ Bond fund has performed and what fees were charged. The document will help you to compare the fund with other funds. AMP Wealth Management New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund is a diversified portfolio that aims to preserve the value of your investment with some capital growth by investing predominantly in New Zealand fixed interest assets.

What are the risks of investing?

Risk indicator for the NZ Bond fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

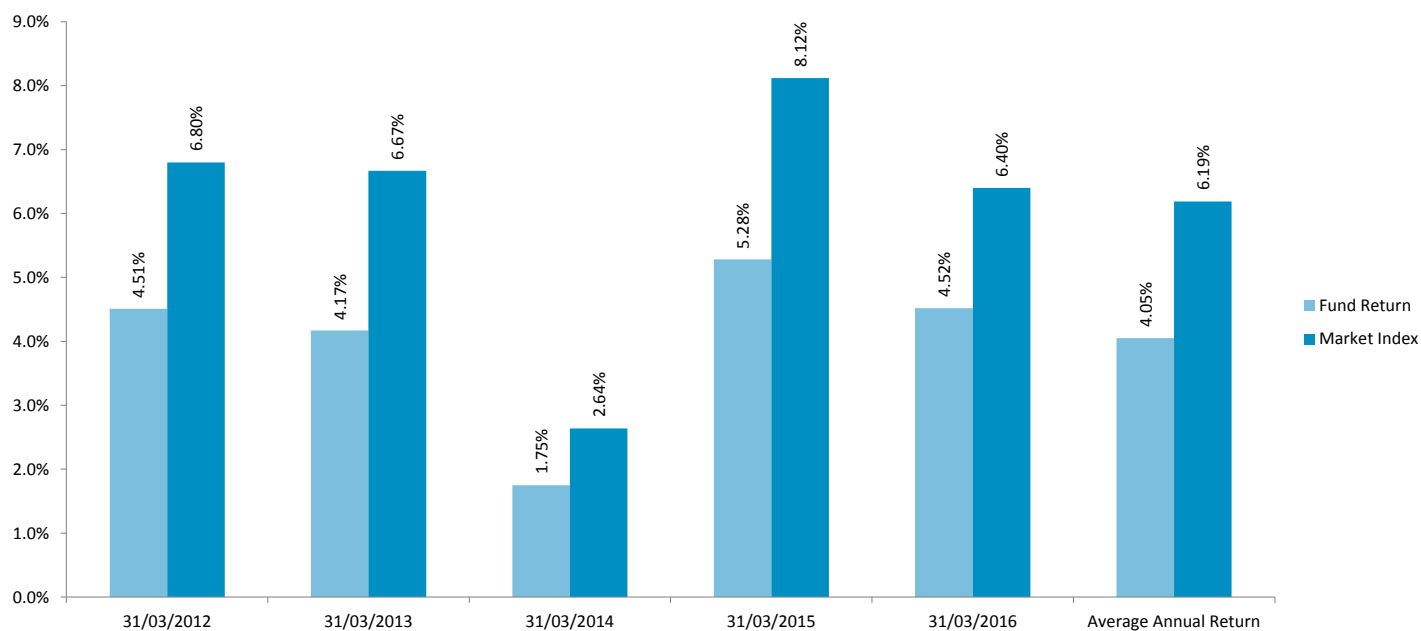
In addition to the general investment risks reflected in the fund's risk indicator, you should be aware this fund is concentrated in a particular asset class and not diversified across multiple asset classes. At any given point, market conditions that cause one asset class to do well may cause another asset class to do badly. This could result in negative or lower than expected returns compared to a fund which is diversified across multiple asset classes.

How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 September 2016.

* Based on increased regulatory costs, including a one off cost associated with registering the Scheme under the Financial Markets Conduct Act 2013, and increased administration expenses, the Manager estimates that the total fund charges for the next scheme year will be .84% of the net asset value.

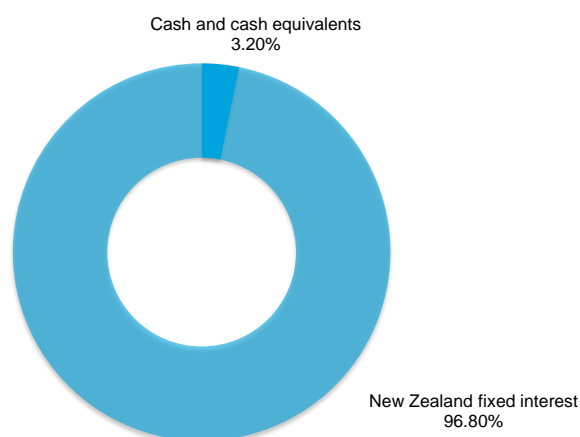
Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$334.00 (that is 3.34% of his initial \$10,000). Craig also paid \$0.00 in other charges. This gives Craig a total return after tax of \$334.00 for the year.
