What is the purpose of this update?

This document tells you how the Passive International Shares (Hedged) fund has performed and what fees were charged. The document will help you to compare the fund with other funds. AMP Wealth Management New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

This is a single sector fund which provides investors exposure to securities in developed equity markets. The fund aims to achieve long term capital growth through exposure to equities of companies listed on stock exchanges around the world (which may include the NZ stock exchange for this fund).

What are the risks of investing?

Risk indicator for the Passive International Shares (Hedged) fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Specific risk

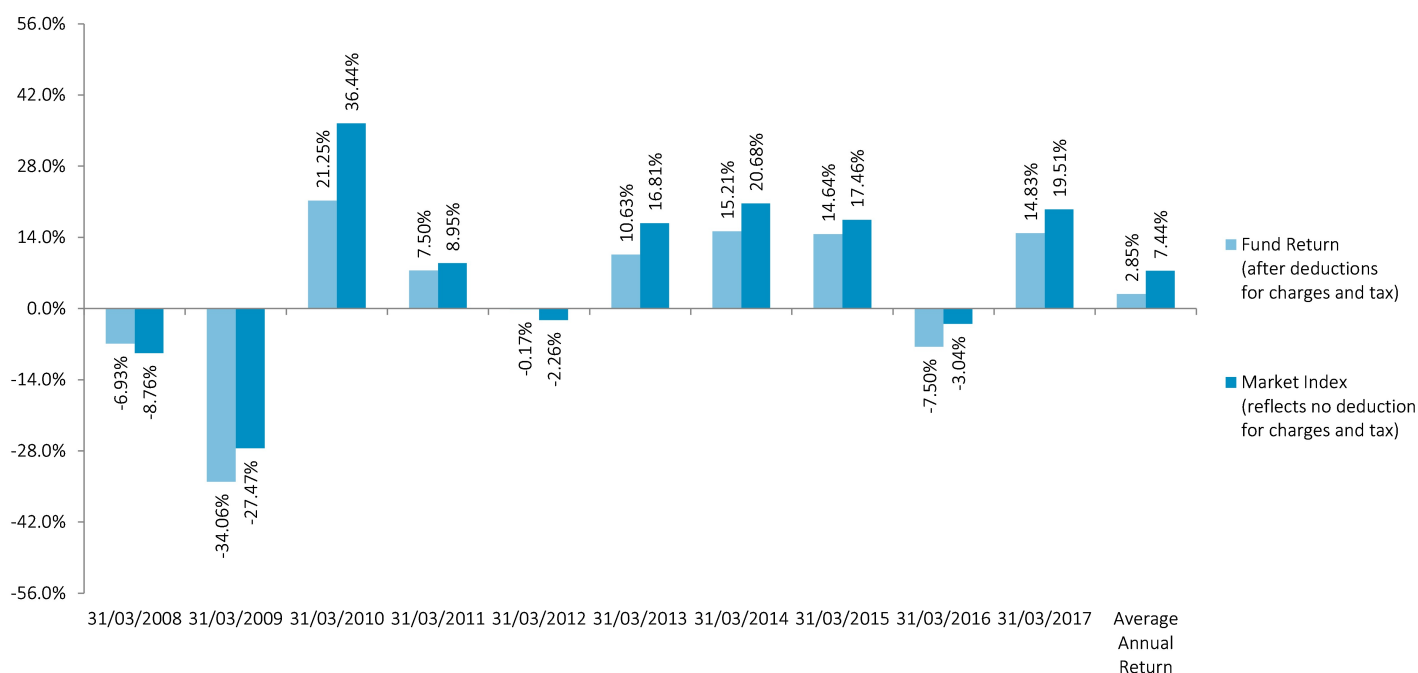
In addition to the general investment risks, you should be aware this fund is concentrated in a particular asset class and not diversified across multiple asset classes. At any given point, market conditions that cause one asset class to perform well may cause another asset class to perform poorly. This could result in negative or lower than expected returns compared to a fund which is diversified across multiple asset classes.

How has the fund performed?

The market index annual return is based on the MSCI World ex Tobacco Net Index (100% hedged to NZD) from 1 October 2017. Prior to 1 October 2017, the market index annual return was based on the MSCI World Index Net (100% hedged to NZD). The new index was the result of a change in the underlying fund's global equity benchmarks which exclude tobacco. Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). We may deduct a contribution fee of up to 5% of each payment for the purchase of units. This fee is agreed between you and your Adviser and is deducted from the amount contributed.

Small differences in fees and charges can have a big impact on your investment over the long term.

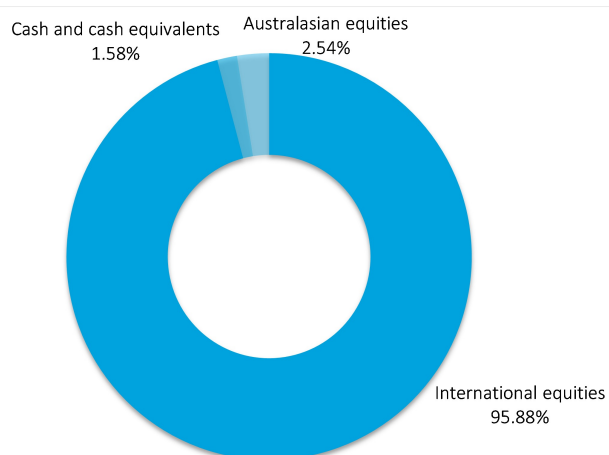
Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$1,669.00 (that is 16.69% of his initial \$10,000). Craig also paid \$0.00 in other charges. This gives Craig a total return after tax of \$1,669.00 for the year.

Currency hedging

The Fund will (or will invest in underlying funds that will) be 100% net hedged to the New Zealand dollar based on the current maximum Prescribed Investor Rate of 28%. The currency hedge is based on a basket of currencies in the key currency blocks, so is a proxy for a full index hedge.

Notes

- 1 The returns include any rebates of management fees which have been paid to qualifying investors. No allowance has been made for any loyalty bonus which certain investors may be entitled to.
- 2 The returns shown for 2016 have been impacted as a result of a tax liability associated with the provision of the loyalty bonus (a feature of the scheme). This has resulted in a downward adjustment in unit prices and will affect the comparability of the 2016 returns against other years.
- 3 The total fund charges exclude loyalty bonuses which have been paid to certain members and the cost of future tax obligations on loyalty bonuses.
- 4 The other management and administration charges include estimates of underlying fund charges provided by underlying fund managers. The balance dates of the underlying fund(s) do not align with the balance date of the fund. To estimate the charges, AMP includes the underlying fund charges as at the relevant underlying fund(s) balance date, adjusted (where required) to reflect any material changes advised to AMP by the relevant underlying manager as having occurred during the intervening period.
