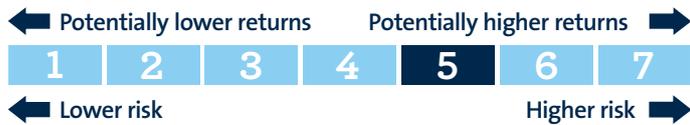
Description of this fund

This is a single sector fund that invests into the BT Wholesale Asian Share Fund which is an actively managed portfolio of Asian equities, excluding Japan and Australia. The fund aims to achieve long term capital growth primarily through exposure to a portfolio of Asian equities.

What are the risks of investing?

Risk indicator for the Asian Shares fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Specific risk


In addition to the general investment risks, you should be aware this fund is concentrated in a particular asset class and not diversified across multiple asset classes. At any given point, market conditions that cause one asset class to perform well may cause another asset class to perform poorly. This could result in negative or lower than expected returns compared to a fund which is diversified across multiple asset classes.


Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$855.00 (that is 8.55% of his initial \$10,000). Craig also paid \$0.00 in other charges. This gives Craig a total return after tax of \$855.00 for the year.

Currency hedging

The fund invests into an underlying Australian domiciled fund. This AUD exposure is generally 100% hedged back to NZD on an after tax basis, assuming a maximum tax rate of 28%. The underlying fund's foreign currency exposure will generally not be hedged to the Australian dollar, but may be from time to time.
