What is the purpose of this update?

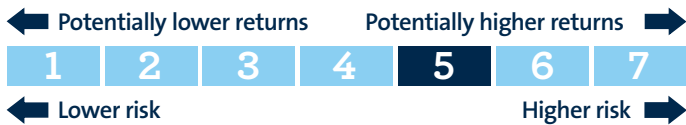
Description of this fund

This is a single sector fund which invests in a selection of equities issued by companies listed on share markets around the world. The fund aims to achieve long term capital growth through exposure to equities of companies listed on stock exchanges around the world (which may include the NZ stock exchange for this fund).

What are the risks of investing?

Risk indicator for the International Equity Trust:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Specific risk

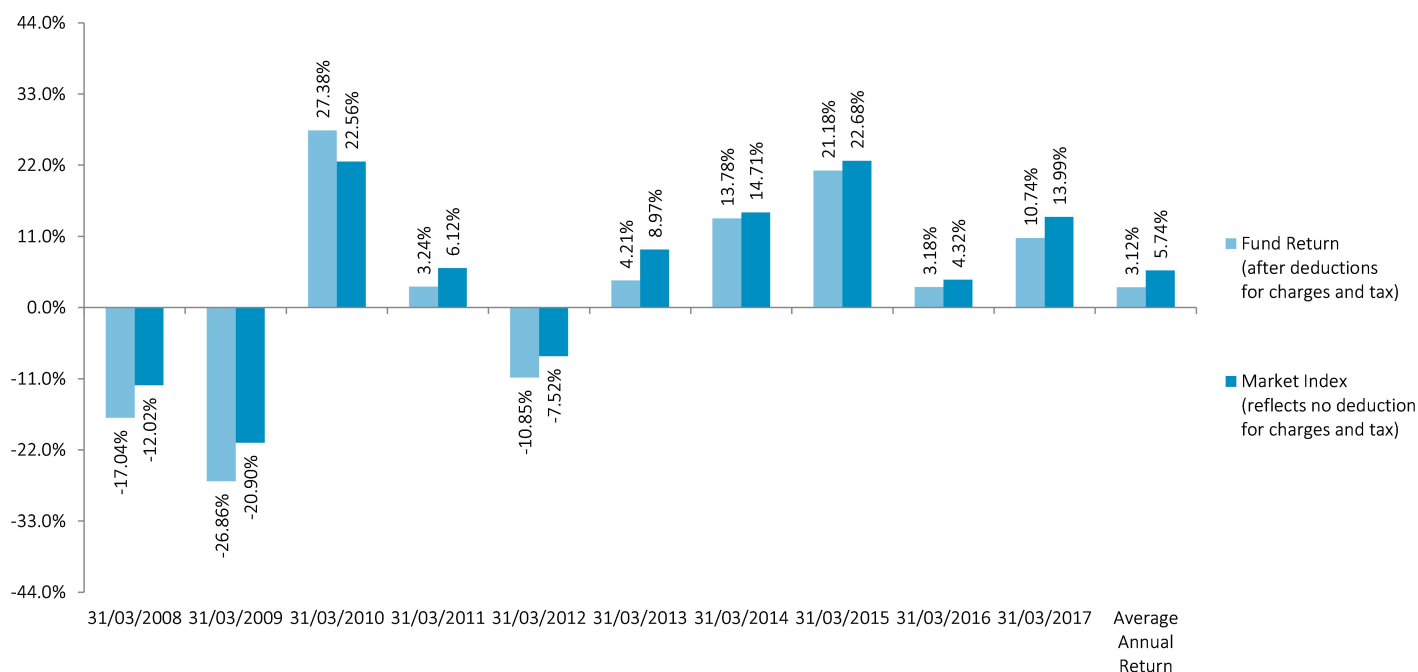
In addition to the general investment risks, you should be aware this fund is concentrated in a particular asset class and not diversified across multiple asset classes. At any given point, market conditions that cause one asset class to perform well may cause another asset class to perform poorly. This could result in negative or lower than expected returns compared to a fund which is diversified across multiple asset classes.

How has the fund performed?

The market index annual return is based on the MSCI World ex Tobacco Net Index (NZD) (Unhedged) from 1 October 2017. Prior to 1 October 2017, the market index annual return was based on the MSCI World Index with net dividends reinvested (NZD) (unhedged). The new index was the result of a change in the underlying fund's global equity benchmarks which exclude tobacco. 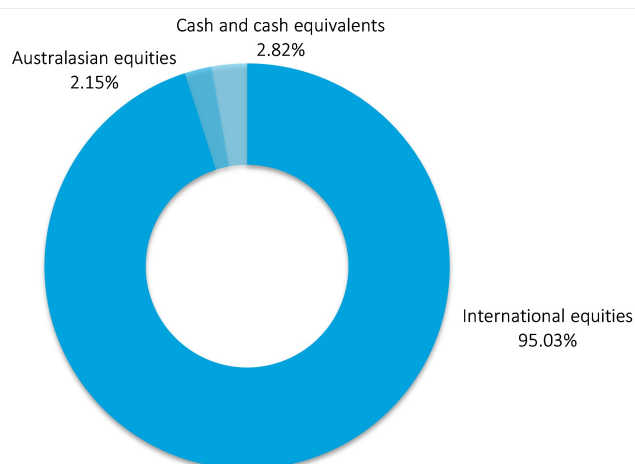
Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$1,856.00 (that is 18.56% of his initial \$10,000). Craig also paid \$0.00 in other charges. This gives Craig a total return after tax of \$1,856.00 for the year.
