



# Fund Update

## What is the purpose of this update?

This document tells you how the AMP Conservative Fund No. 2 has performed and what fees were charged. The document will help you to compare the fund with other funds. AMP Wealth Management New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The fund has a well-diversified portfolio that primarily invests in lower-risk income assets with a conservative allocation to growth assets. The fund aims to achieve modest to medium returns, in exchange there may be small movements up and down in the value of your investments. This fund is closed to new investors.

## What are the risks of investing?

Risk indicator for the AMP Conservative Fund No. 2:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

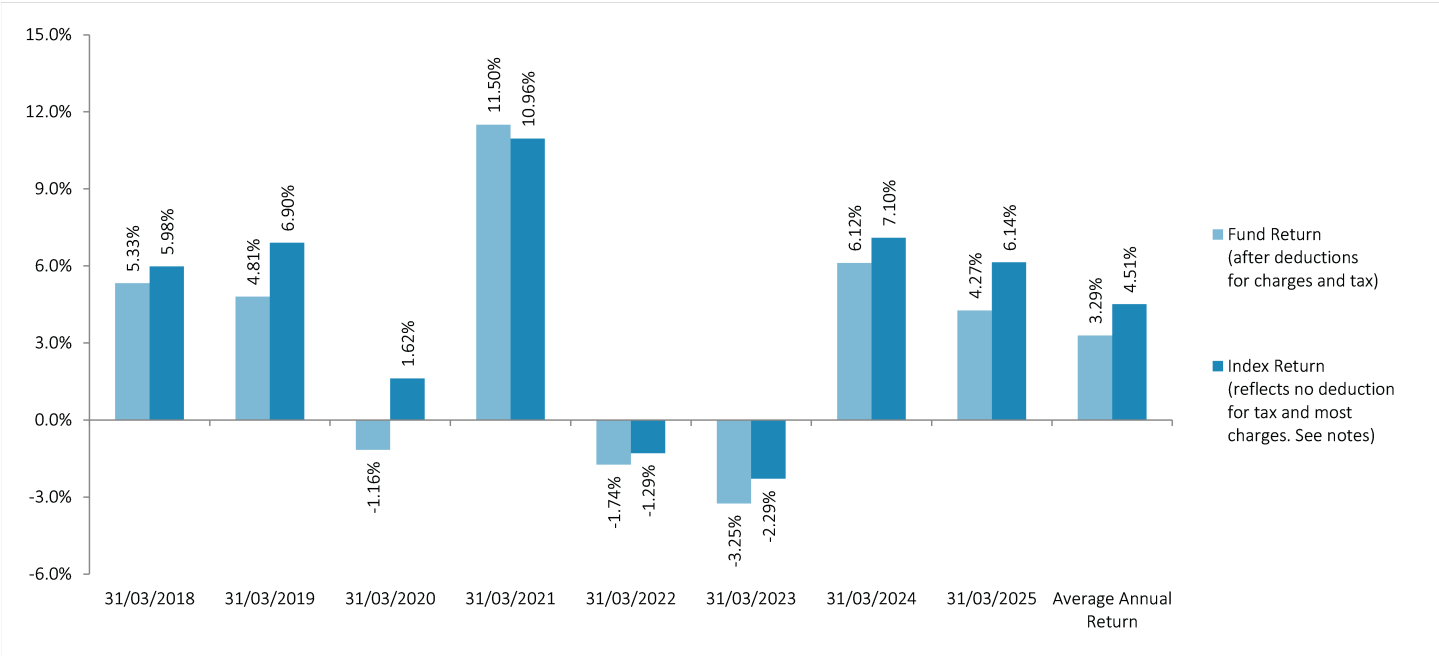

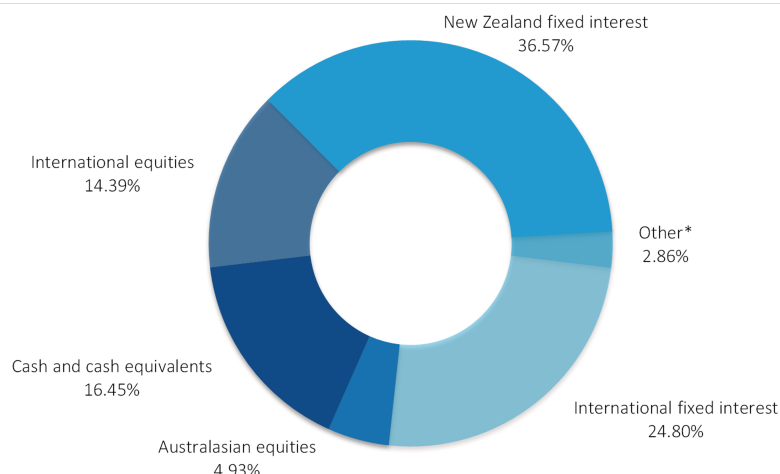
Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$616.00 (that is 6.16% of his initial \$10,000). Craig also paid \$23.40 in other charges. This gives Craig a total return after tax of \$592.60 for the year.

Currency hedging

- The fund will (or will invest in underlying funds that will) target:
- fully hedging foreign currency exposure from International fixed interest and Australasian equities;
  - hedging foreign currency exposure from International equities – Developed markets at 60% hedged to New Zealand dollars; and
  - not hedging foreign currency exposure from International equities – Emerging markets.
- a range of foreign currency hedging may be used at the discretion of the Manager - Other - Direct infrastructure.

Notes

- 1 On 26 March 2024 AMP Wealth Management New Zealand Limited (AMPWM) replaced Nikko Asset Management Limited (Nikko AM) as the underlying fund manager of the Nikko AM Conservative Fund. The fund performance table and graph relates to both AMPWM and Nikko AM. The risk indicator is based on returns data for this fund for the past 5 years and may differ from the risk indicator of the AMP Conservative Fund.
- 2 From 26/03/2024 we have used a composite index to calculate market index returns for all asset classes with the exception of Other – Direct Infrastructure where no index is available. Prior to 26/03/2024 we used a composite of market indices and peer group for relevant asset classes with the exception of Other – Alternative Equity Strategies where no index was available. A composite index is calculated using the target investment mix weightings of the underlying appropriate market indices and where applicable, peer group indices for the asset classes that the fund invested into. The return for the peer group index reflects deductions for fund charges and trading expenses, but before tax. A composite index may be a less reliable indicator of performance than an appropriate market index.
- 3 The total fund charges are inclusive of any applicable GST.
- 4 The other management and administration charges include estimates of underlying fund charges provided by underlying fund managers.
- 5 The actual investment mix and top ten investments have been calculated excluding cash and cash equivalents held for operational purposes.
