What is the purpose of this update?

This document tells you how the SuperLife Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. AMP Wealth Management New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund's returns are generally expected to be the highest of the SuperLife diversified funds. The fund aims to provide high total returns allowing for large movements of value up and down.

What are the risks of investing?

Risk indicator for the SuperLife Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

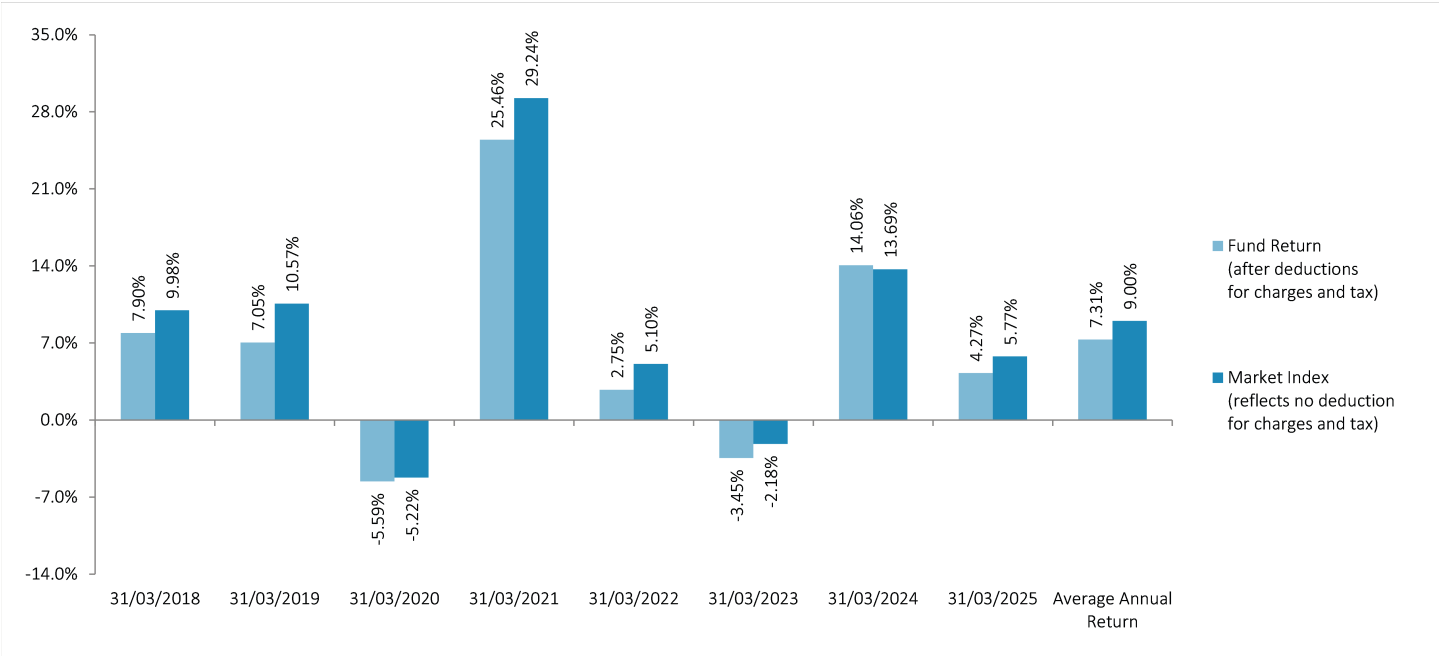

How has the fund performed?

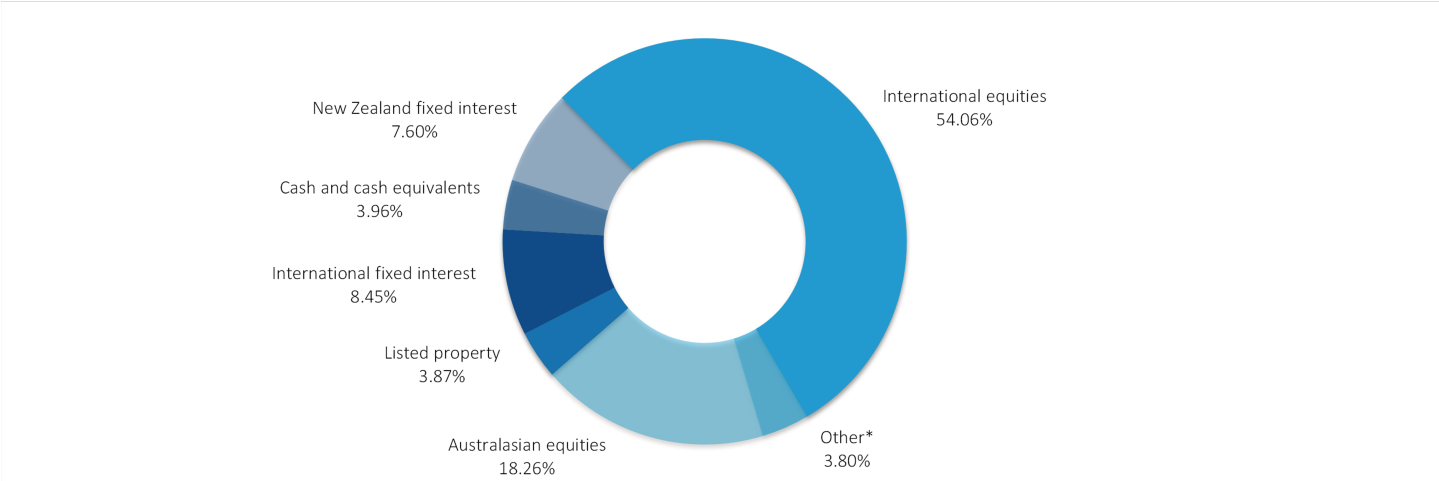
Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$1,165.00 (that is 11.65% of his initial \$10,000). Craig also paid \$23.40 in other charges. This gives Craig a total return after tax of \$1,141.60 for the year.

Currency hedging

The fund will (or will invest in underlying funds that will) actively manage currency hedging around the following target levels:

- a fully hedged foreign currency exposure arising from global bonds (including Government, Inflation-linked and corporate), listed property and Other category;
- a 50% hedge of foreign currency exposure arising from Australasian equities (only applies to Australian equities) and International equities (excluding emerging markets); and
- no hedge on the foreign currency exposure arising from commodities.
