From 1 April 2020, Inland Revenue may do a calculation to work out any underpaid or overpaid PIE Tax. If you should have been on a lower PIR and have overpaid tax, Inland Revenue may give you a refund. If you should have been on a higher PIR, additional tax may be payable by you.
