AMP KiwiSaver Scheme - AMP Balanced Fund

What is the purpose of this statement?

This statement provides key information about the AMP KiwiSaver Scheme AMP Balanced Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The fund has a well-diversified portfolio that has a balance of risk through holding growth assets and an allocation to lower risk income assets. The fund aims to achieve medium returns - in exchange there will be some movements up and down in the value of your investments.



How has the fund performed?

How has the fund performed in the past?

What fees were members charged?

The returns above are after deductions for **fund fees**². These fees were last totalled up for the year to 31 March 2014 and were:

Members were also charged **membership fees**³ of **\$35.50** over the year to 31 March 2014.


Example of how this applies to a member

Sarah had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Sarah received a return after fund fees and tax were deducted of \$887 (that's 8.87% of her initial \$10,000). Sarah also paid \$35.50 in membership fees³. This gives Sarah a total return of \$851.50 for the year.

Notes

¹Returns in this statement are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax rate may be lower.

²Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance). From 1 July 2014 the recovery of costs and expenses from the fund or members' accounts commenced.

³Membership fees are the fixed dollar charges for membership in a KiwiSaver scheme. The membership fee was reduced from \$3.00 per member per month (\$36.00 annually) to \$2.95 per member per month (\$35.40 annually) on 4 June 2013 – which resulted in an annual fee for the year ending 31 March 2014 of \$35.50. The membership fee was reduced from 1 July 2014 to \$1.95 per member per month (\$23.40 annually). A lower membership fee may apply to a member if their employer has established an employer plan within the AMP KiwiSaver Scheme.

⁴These individuals are members of the AMP Financial Services Investment Committee. The other members are Fiona Ann Oliver (General Manager, Wealth Management), Bevan Trevor Graham (Chief Economist, AMP Capital), Nicholas Paul Edward Scarlett (General Manager, Proprietary Distribution), and Christopher James White (Managing Director, Spicers). This Committee makes investment decisions in relation to the fund on behalf of the manager. Members do not participate in any decisions where a conflict of interest arises. Peter Raymond Verhaart and Bevan Trevor Graham are not directors or employees of the manager.

⁵The total fund fees were incorrectly stated as 1.05% (which are made of annual management fee of 0.96% and other fees and costs of 0.09%) in the Quarterly Disclosure Statement that was published on 18 July 2014. This has now been corrected to 1.04% (which are made up of annual management fee of 0.95% and other fees and costs of 0.09%).
