## AMP KiwiSaver Scheme - AMP Conservative Fund

### What is the purpose of this statement?

This statement provides key information about the AMP KiwiSaver Scheme AMP Conservative Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

### Description of the fund

The fund has a well-diversified portfolio that has a conservative allocation to growth assets but is primarily invested in lower risk income assets. The fund aims to achieve modest to medium returns - in exchange there may be small movements up and down in the value of your investments.

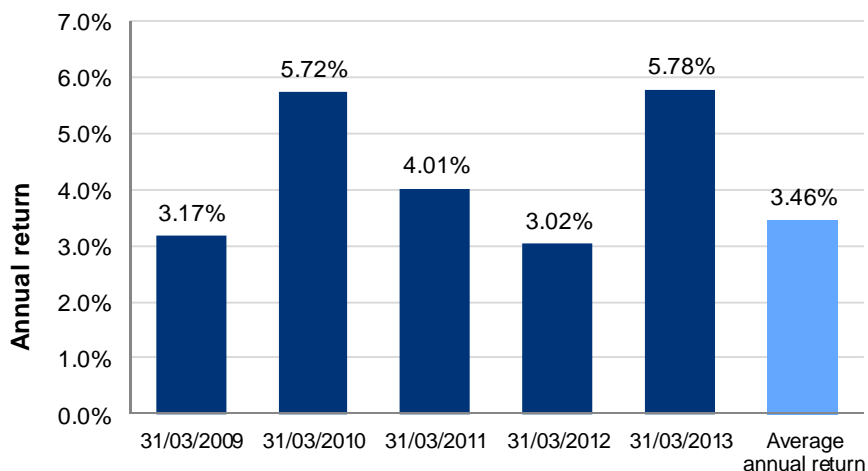

### How has the fund performed in the past?

## What fees were members charged?

The returns above are after deductions for **fund fees**<sup>2</sup>. These fees were last totalled up for the year to 31 March 2013 and were:

**Total fund fees** **0.90% of members' investments**

Which are made up of:

Annual management fee	0.84%
Performance-based fees	0.00%
Other fees and costs	0.06%

Members were also charged **membership fees**<sup>3</sup> of **\$36.00** over the year to 31 March 2013.

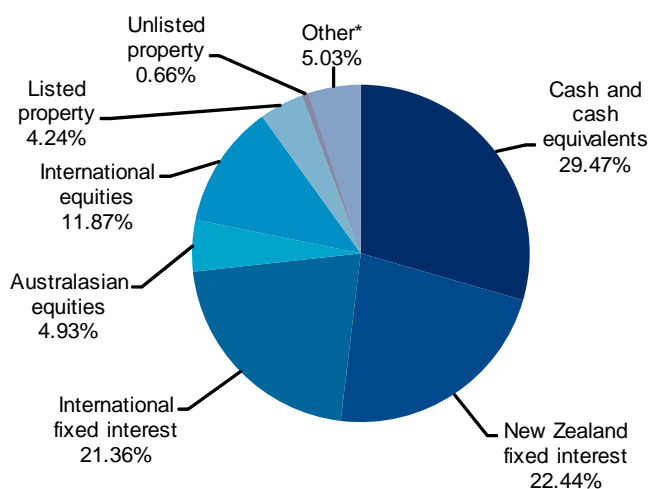
## Example of how this applies to a member

Alexandra had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Alexandra received a return after fund fees and tax were deducted of \$408 (that's 4.08% of her initial \$10,000). Alexandra also paid \$36.00 in membership fees<sup>3</sup>. This gives Alexandra a total return of \$372 for the year.

## Notes

<sup>1</sup>Returns in this statement are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax rate may be lower.

<sup>2</sup>Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance).

<sup>3</sup>Membership fees are the fixed dollar charges for membership in the KiwiSaver scheme. The membership fee was reduced from \$3.00 per member per month (\$36.00 annually) to \$2.95 per member per month (\$35.40 annually) on 4 June 2013. A lower membership fee may apply to a member if their employer has established an employer plan within the AMP KiwiSaver Scheme.

<sup>4</sup>These individuals are members of the AMP Financial Services Investment Committee. The other members are Fiona Ann Oliver (General Manager, Wealth Management), Bevan Trevor Graham (Chief Economist, AMP Capital), Nicholas Paul Edward Scarlett (General Manager, Proprietary Distribution), and Christopher James White (Managing Director, Spicers). This Committee makes investment decisions in relation to the fund on behalf of the manager. Members do not participate in any decisions where a conflict of interest arises. Peter Raymond Verhaart and Bevan Trevor Graham are not directors or employees of the manager.
