AMP KiwiSaver Scheme — Tyndall Balanced Fund

What is the purpose of this statement?

This statement provides key information about the AMP KiwiSaver Scheme Tyndall Balanced Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The fund has a well-diversified portfolio that has an allocation to growth and income assets and aims to be widely diversified not only between asset classes, but also within asset classes and between domestic and global investments. The fund aims to achieve medium level returns with medium levels of volatility and investment risk.

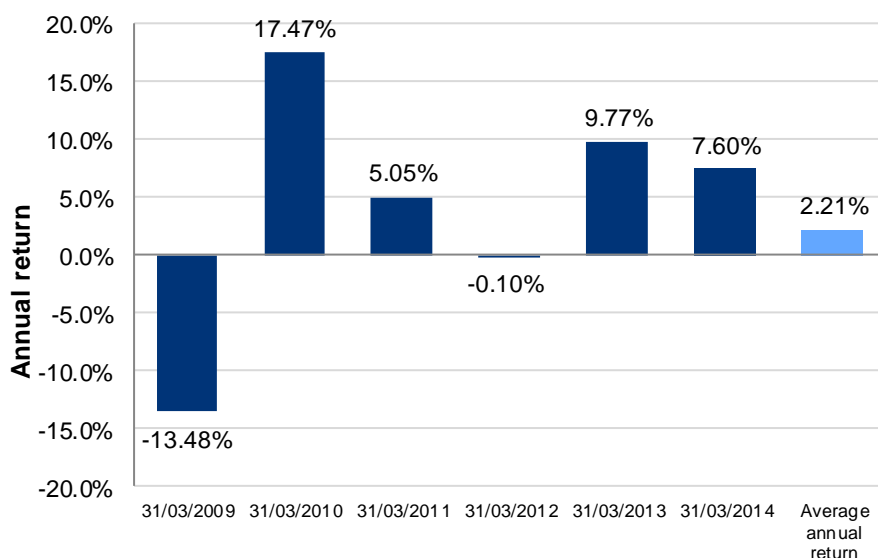

How has the fund performed in the past?

What fees were members charged?

The returns above are after deductions for **fund fees**². Over the past year these were:

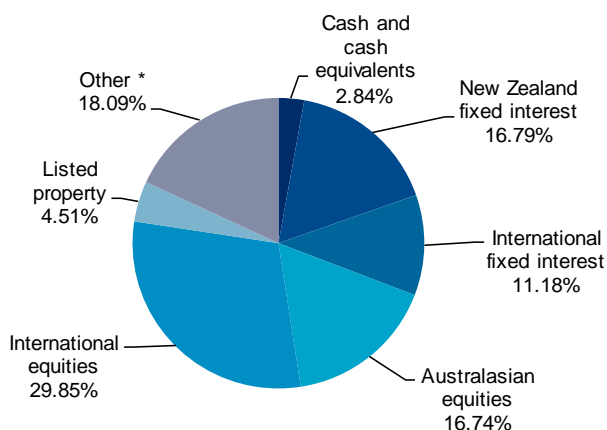
Example of how this applies to a member

Brooke had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Brooke received a return after fund fees and tax were deducted of \$760 (that's 7.60% of her initial \$10,000). Brooke also paid \$35.50 in membership fees³. This gives Brooke a total return of \$724.50 for the year.

Notes

¹Returns in this statement are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax rate may be lower.

²Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance). From 1 July 2014 the recovery of costs and expenses from the fund or members' accounts will commence.

³Membership fees are the fixed dollar charges for membership in the KiwiSaver scheme. The membership fee was reduced from \$3.00 per member per month (\$36.00 annually) to \$2.95 per member per month (\$35.40 annually) on 4 June 2013 – which resulted in an annual fee for the year ending 31 March 2014 of \$35.50. The membership fee will be reduced from 1 July 2014 to \$1.95 per member per month (\$23.40 annually). A lower membership fee may apply to a member if their employer has established an employer plan within the AMP KiwiSaver Scheme.

⁴These individuals are members of the AMP Financial Services Investment Committee. The other members are Fiona Ann Oliver (General Manager, Wealth Management), Bevan Trevor Graham (Chief Economist, AMP Capital), Nicholas Paul Edward Scarlett (General Manager, Proprietary Distribution), and Christopher James White (Managing Director, Spicers). This Committee makes investment decisions in relation to the fund on behalf of the manager. Members do not participate in any decisions where a conflict of interest arises. Peter Raymond Verhaart and Bevan Trevor Graham are not directors or employees of the manager.

Corrections to this Annual Disclosure Statement

⁵The total fund fees were incorrectly stated as 1.42% (which are made up of annual management fee of 0.94% and other fees and costs of 0.48%) in the Annual Disclosure Statement that was published on 26 June 2014. This has now been corrected to 1.24% (which are made up of annual management fee of 0.95% and other fees and costs of 0.29%).
