What is the purpose of this update?


Description of this fund

The fund has a diversified portfolio that primarily invests in lower-risk income assets with a conservative allocation to growth assets. The fund aims to preserve the value of your investments and achieve modest returns, in exchange there may be small movements up and down in the value of your investments. This fund is closed to new investors.

What are the risks of investing?

Risk indicator for the AMP Defensive Conservative Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?


Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$618.00 (that is 6.18% of his initial \$10,000). Craig also paid \$23.40 in other charges. This gives Craig a total return after tax of \$594.60 for the year.

Currency hedging

The fund will (or will invest in underlying funds that will) target:

- fully hedging foreign currency exposure from International fixed interest and Australasian equities;
- hedging foreign currency exposure from International equities Developed markets at 50% hedged to New Zealand dollars; and
- not hedging foreign currency exposure from International equities Emerging markets.

The\ fund\ performance\ in\ the\ table\ shows\ fund\ performance\ which\ relates\ to\ both\ AMPWM$ (with support from BlackRock Investment Management (Australia) Limited) and AMP Capital, now known as Macquarie.
- The total fund charges are inclusive of any applicable GST.
- The other management and administration charges include estimates of underlying fund charges provided by underlying fund managers.
- The actual investment mix and top ten investments have been calculated excluding cash and cash equivalents held for operational purposes.
