
# Description of this fund

This is a single sector fund with exposure to a diversified international equities portfolio. The fund aims to achieve long term capital growth through exposure to equities of companies listed on stock exchanges around the world.

# What are the risks of investing?

Risk indicator for the AMP International Shares Fund No. 2:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

#### Specific risk

This could result in negative or lower than expected returns compared to a fund which is diversified across multiple asset classes.




## Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$2,069.00 (that is 20.69% of his initial \$10,000). Craig also paid \$23.40 in other charges. This gives Craig a total return after tax of \$2,045.60 for the year.
