## What is the purpose of this update?

This document tells you how the AMP Conservative Fund (Lifesteps) has performed and what fees were charged. The document will help you to compare the fund with other funds. AMP Wealth Management New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The fund has a well-diversified portfolio that has a conservative allocation to growth assets but is primarily invested in lower risk income assets. The fund aims to achieve modest to medium returns, in exchange there may be small movements up and down in the value of your investments.

## What are the risks of investing?

Risk indicator for the AMP Conservative Fund (Lifesteps):



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

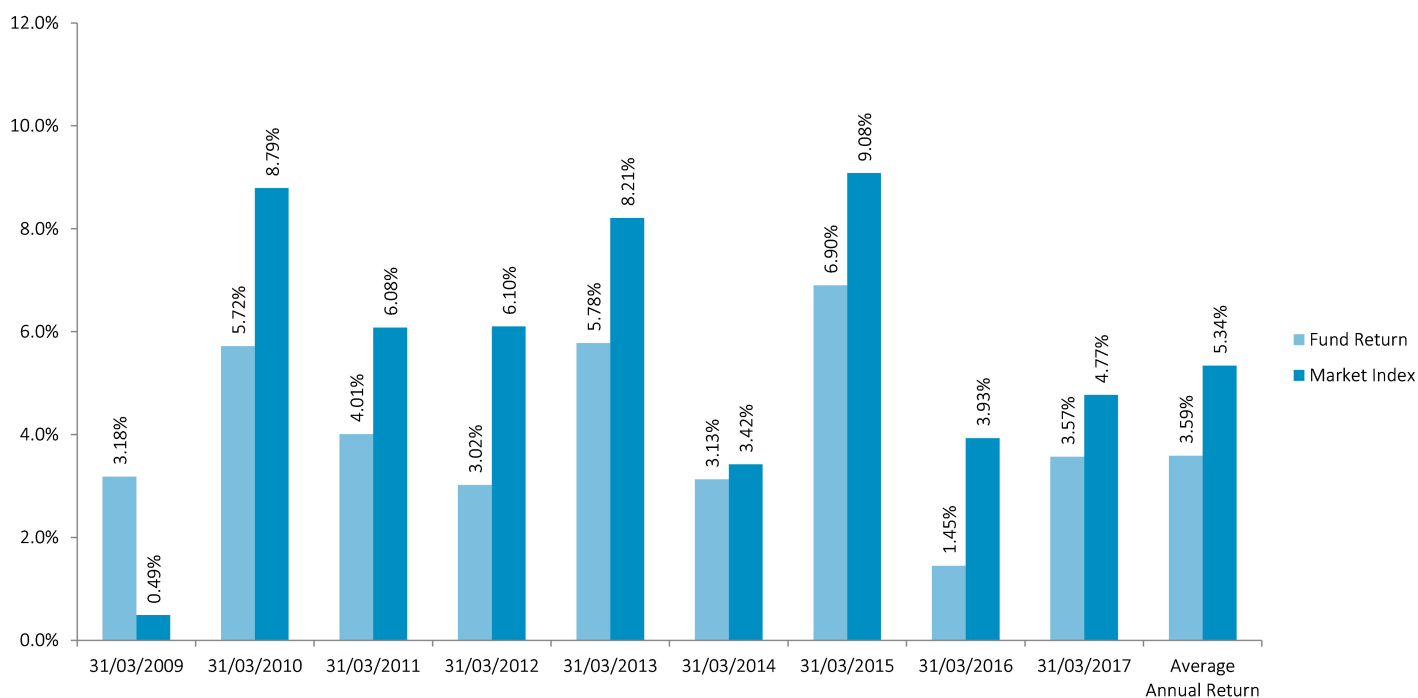

## How has the fund performed?

## Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2017.

Small differences in fees and charges can have a big impact on your investment over the long term.

## Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$335.00 (that is 3.35% of his initial \$10,000). Craig also paid \$23.40 in other charges. This gives Craig a total return after tax of \$311.60 for the year.

## Currency hedging

The Fund will (or will invest in underlying funds that will) hedge foreign currency exposure for all asset classes, with the exception of International equities – Emerging markets, where currency exposure will be unhedged, and Australasian equities and International equities – Developed markets, where currency exposure is actively managed.
