Fund Update

This fund update was first made publicly available on 23 June 2017

This is a replacement fund update. It replaces the 30 September 2016 AMP KiwiSaver Scheme Nikko AM Balanced Fund fund update first made publicly available on 31 October 2016. The following changes have been made in the replacement fund update:

- total fund charges, management and administration charges and other management and administration charges have been updated; and
- a new footnote 2 has been added which explains why certain underlying fund manager charges, which make up the other management and administration charges, have had to be estimated.

What is the purpose of this update?

This document tells you how the Nikko AM Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. AMP Wealth Management New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund has a well-diversified portfolio that has an allocation to growth and income assets and aims to be widely diversified not only between asset classes, but also within asset classes and between domestic and global investments. The fund aims to achieve medium level returns with medium levels of volatility and investment risk.

What are the risks of investing?

Risk indicator for the Nikko AM Balanced Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

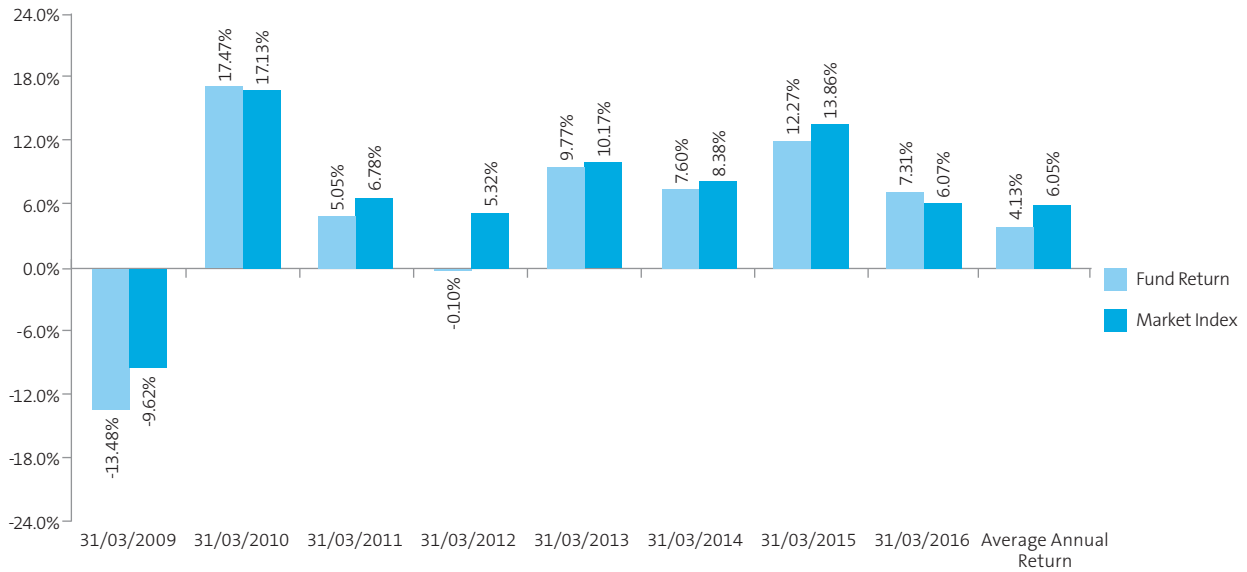

How has the fund performed?

Annual Return Graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 September 2016.

*An understatement of the underlying fund manager's charges, which form part of the other management and administration charges, has been identified and corrected in this replacement fund update. This has resulted in the estimated total fund charges increasing from 1.51% to 1.74%.

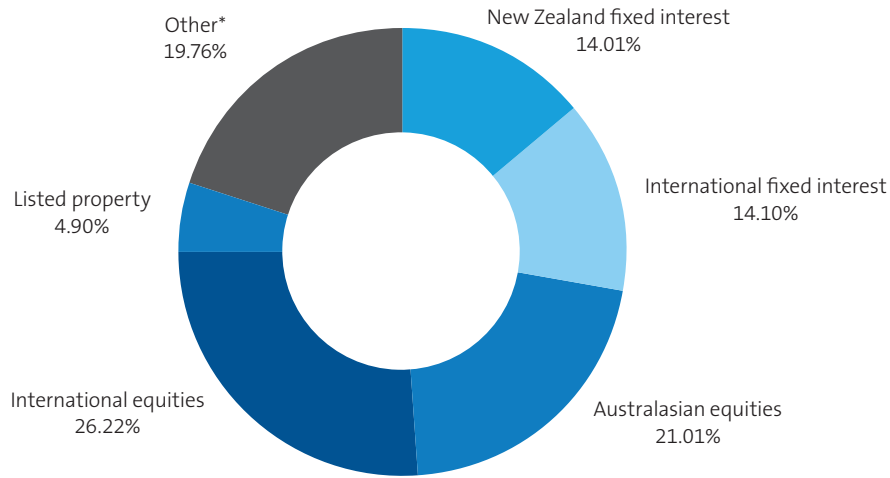
Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$259.00 (that is 2.59% of his initial \$10,000). Craig also paid \$23.40 in other charges. This gives Craig a total return after tax of \$235.60 for the year.

Notes

- ¹ The total fund charges include administration fees that while calculated by reference to investment balances, are not allocated to specific funds. As the actual amount of the fee charged to the fund cannot be calculated, an estimate has been used. The estimate has been made by allocating the total of this fee for the funds other than the AMP Default Fund, equal to the proportion of the average net assets of the fund for the year to 31 March 2016 to the total average net assets of the funds other than the AMP Default Fund for the year to 31 March 2016.
- ² Other management and administration charges include charges by underlying fund managers who are not subject to New Zealand law and are unable to provide us with actual figures. In these circumstances, AMP Wealth Management New Zealand Limited (AMP) is not able to verify that these charges have been calculated in accordance with the requirements of New Zealand law. Therefore, an estimate has been prepared on the basis of the information provided, after AMP has made reasonable endeavours to obtain all relevant information for the purposes of preparing the fund update. Estimates include actual underlying funds costs and expenses provided to AMP for the period to 31 March 2016 apart from a component which is based on estimated costs and expenses provided by an underlying fund manager for the year ending 31 December 2015. This is then applied to the average investment in the fund for the 12 month period ending 31 March 2016.
- ³ Note that the amount of the member fee could be less if you are in an employer plan and the impact of these fees on you could be less than that set out in the example – check your Member Booklet for details.
- ⁴ The top ten investments and actual investment mix have been calculated excluding cash and cash equivalents held for operational purposes.
- ⁵ These individuals are members of the AMP Financial Services Investment Committee. The other members are Grant David Hassell (Managing Director, AMP Capital New Zealand) and Jeffery Darren Ruscoe (Chief Customer Officer, AMP Financial Services). This Committee makes investment decisions in relation to the fund on behalf of the Manager. Members do not participate in any decisions where a conflict of interest arises.
