What is the purpose of this update?

This document gives you information about AMP Growth Managed Fund and what fees are charged. The document will help you to compare the fund with other funds. AMP Wealth Management New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund has a well-diversified portfolio that aims to provide growth, primarily through holding growth assets diversified with a lower allocation to lower-risk income assets. The fund aims to achieve medium to high returns, in exchange there will be larger movements up and down in the value of your investments.

What are the risks of investing?

Risk indicator for the AMP Growth Managed Fund¹:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

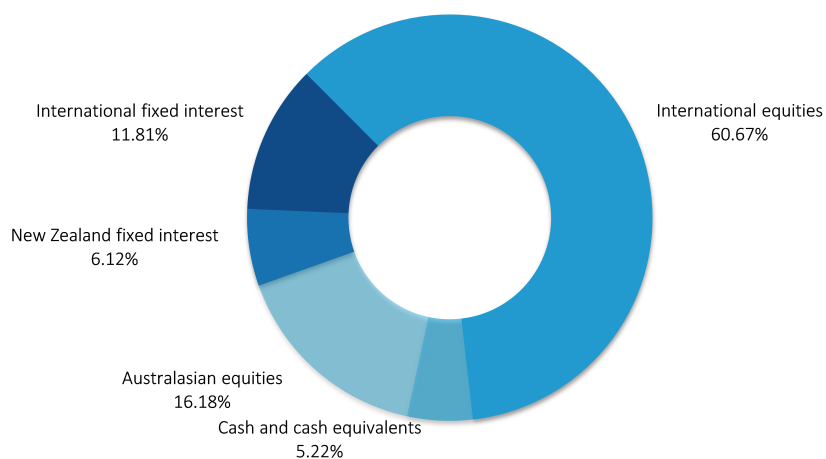
Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig incurred a loss after fund charges were deducted of \$1,184.00 (that is -11.84% of his initial \$10,000). Craig also paid \$0.00 in other charges. This gives Craig a total loss after tax of \$1,184.00 for the year.⁵

Currency hedging

The Fund will (or will invest in underlying funds that will) target:

- fully hedging foreign currency exposure from International fixed interest and Australian equities;
- hedging foreign currency exposure from International equities - Developed markets at 50% hedged to New Zealand dollars; and
- not hedging currency exposure from International equities - Emerging markets.

Notes

- 1 As the fund started on 18 May 2022, actual returns for the last five years are not available. To calculate the risk indicator for the five year period up to the date of this fund update, a combination of market index returns and actual fund returns have been used where relevant. We consider this to be the most appropriate way to calculate the risk indicator, but as a result of this calculation, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund than it would if actual returns for the last five years were able to be used.
- 2 The total fund charges are inclusive of any applicable GST.
- 3 As the fund started on 18 May 2022, historical fee information prior to that date is not available. The total fund charges shown include our best estimates of the amount of costs and expenses that will be charged to the fund. These have been estimated as a percentage of the fund's net asset value and include both expenses expected to be incurred by the fund and fees (and costs) expected to be charged by the underlying funds. These include Trustee's fee, custody, accounting, audit and regulatory compliance costs. These charges are estimated.
- 4 The other management and administration charges include estimates of underlying fund charges provided by underlying fund managers.
- 5 As the fund started on 18 May 2022, this calculation is based on the market index return for the past year and treats all investment returns as taxable.
- 6 The actual investment mix and top ten investments have been calculated excluding cash and cash equivalents held for operational purposes.
