* The Administration fee is charged as a percentage (currently 0.150% for the Default Fund and 0.525% for all other Funds) of the gross asset value of each Fund and is deducted each month by cashing up units from a member's account. The Member fee is currently \$1.95 per month per member and is deducted each month by cashing up units from a member's account.
